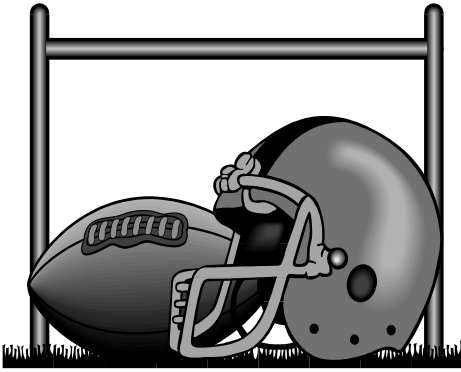

League Actions

***NOTE - DUE TO CONTINUED INSTANCES OF BAITING, TAUNTING, AND DEROGATORY REMARKS DURING AND AFTER GAME PLAY, THE FOLLOWING SANCTIONS HAVE BEEN ISSUED:**

(1) SHOULD THE PANTHERS AND BREW CREW BE SCHEDULED TO MEET DURING THE PLAYOFFS, THE GAME WILL NOT BE PERMITTED TO TAKE PLACE AND AN AUTOMATIC DOUBLE-FORFEIT WILL BE RECORDED.

(2) COORDINATORS AND OFFICIALS WILL BE ADVISED THAT THE PANTHERS TEAM WILL NOT BE PERMITTED TO HAVE SPECTATORS ATTEND GAMES THROUGHOUT THE REMAINDER OF THE REGULAR SEASON AND PLAYOFF SCHEDULE. SHOULD SPECTATORS BE ON-SITE, THE GAME WILL END AND RESULT IN A PANTHERS FORFEIT.

NOTE: Suspended players are not permitted to be at league playing sites while serving suspensions. Players and managers are not permitted to confront staff or officials to argue disciplinary actions. Any violation of these rules or further incidences of misconduct will result in longer-term suspensions.
