#15 Rob Traynor Pizza By Elizabeth	Red card – excessive cautions (unsportsmanlike conduct)	One (1) game suspension to be served 6/9 vs Boys Town, or next game played if above is cancelled.
#22 Dave Dease Pizza By Elizabeth	Red card – violent conduct	Three (3) game suspension to be served 6/9 vs Boys Town, 6/14 vs Guinness FC, and 6/16 vs FC World Eleven, or next three (3) games played if any of the above are cancelled. Probation through Aug 31, 2012.
#4 Luis Ramon Bolerano U Peru	Red card – violent conduct	Three (3) game suspension to be served 6/7 vs Boys Town, 6/14 vs KW Solar, and 6/16 vs Hockessin SC, or next three (3) games played if any of the above are cancelled. Probation through Aug 31, 2012.

The following sanctions are issued as a result of an incident after the game:

1. Game #11 between Pizza By Elizabeth and U Peru, which was terminated early due to poor behavior of the teams, is a double forfeit.
2. Pizza By Elizabeth will forfeit its next game, Game #41 vs Boys Town.
3. U Peru will forfeit its next game, Game #24 vs Boys Town.
4. Both teams are placed on probation through the end of the summer league. All future red cards will result in increased suspensions for the players involved.
5. The following players are suspended for one (1) year from all New Castle County Sports programs and five (5) years from all New Castle County activities (indoor and outdoor) at the Kirkwood Soccer Complex:
